**Support Services** – Kate DeMeester-Lane, Library Services Manager During October, I was fortunate to attend the annual Arizona Library Association conference, and to present on our partnership with OverDrive to provide digital materials for the community. Since circulation has been increasingly digital since 2020, we have focused more attention on our digital collections and our digital budgets. Sharing our strategies with the broader Arizona library community was a valuable opportunity.

### Collection Development/Technical Services/Delivery - Victoria Salaiko, Librarian III

This month, Pima County Public Library cardholders can now access new content in Kanopy, a digital streaming service for movies and shows. This includes content from major suppliers MGM, MHz, and Warner Bros. At first, this content was blocked to PCPL users, due to its high cost. Recently, Kanopy changed its access model, using tickets instead of credits. This allowed PCPL to unblock this content, now allowing full access to Kanopy's catalog, to our cardholders. With the old credit model, library users could access a set number of films each month, with the cost to the library varying based on what cardholders chose to watch. To avoid overspending, we were unable to supply the more expensive films through Kanopy. Now, with the ticket model, customers receive the same number of tickets each month, with films requiring varying numbers of tickets to play. Inexpensive films will use 1 ticket, more expensive films may use 4 tickets. This new model allows us to provide increased content, without increased cost.

Our Technical Services Team (TSV) met with staff at the Bear Canyon Library, to support them with their upcoming temporary closure, for building maintenance. No date has been set for this closure, but we are making preparations now, to ensure a smooth transition for their customers and staff. Public libraries have a dynamic flow of materials in and out of their facility every day. TSV assists the branch in making decisions for managing the delivery of new books and other materials, serials like newspapers and magazines, the materials arriving for their hold shelf, Interlibrary Loan Materials, and more. We customize the plan for managing the start and stop of movement for these key resources, based on the length of the closure, and the needs of the community.
